Data Collection

For the purposes of our services

Personal data in relation to our clients may be gained from multiple places – contact forms, contact with our employees, emails, online checkouts or from
publicly available sources such as your website. This information may include (but not be limited to) the following type of personal identifiable information:

Name, job title, company, postal address, email address, telephone number. This can also include information provided from you about other colleagues were we assume you have permission from them to share this data.

For the purpose of client direct mails

• If a client engages us to carry out a direct mail campaign (acting on their behalf), they must provide a list of data, to process through our email marketing platform. They are responsible for making sure that any list supplied complies with all data protection legislation. All data will be held on our servers for a period of 3 months for statistical purposes and will then be deleted.

For the purposes of eCommerce platforms

 All data collected from eCommerce stores are owned by the client and may not be shared with third parties. We do not store credit card information on our servers. All payments are processed by a nominated third party payment processor agreed with the client prior to implementation.

Data Management

- We will take specific steps as required by applicable data protection laws to ensure that appropriate security measures are put in place, to protect your
 personal information from unlawful and unauthorised processing and accidental data breaches or destruction.
- We will retain client's information for as long as necessary to comply with the active.
 agreement between the buyer and seller. Once the agreement has ended, we hold their data for 3 years, unless requested by the client to be removed from our database.
- We do not share personal information with companies outside of The Studio 4 Creative Ltd other than those who have a part in the running of the client's business activities. These companies use the information provided solely for this purpose and at no time will the information be used for commercial gain.
- · All intellectual property hosted by The Studio 4 Creative Ltd belongs to the client once any related invoices have been paid in full.
- Direct mail lists that we have obtained through an agreement with our clients will be held for a period of 3 months after the email has been sent and then the information will be deleted from our system.

Your responsibility

- It is expected that all clients will keep secure the login name and password specified on your online customer order form. It is part of any agreement with
 us that this information is not passed to any unauthorised person or third party. The Studio 4 Creative Limited will not be held responsible for any data
 breach in the event that your login name and password is used by any unauthorised person or company. You also agree to indemnify The Studio 4
 Creative Ltd against any charges or costs that may arise from any breach.
- · That you make regular back-ups of your data and files that are used in connection with the service by The Studio 4 Creative Ltd.
- You do not upload any virus to the website which could infect our server or other equipment;
- You do not upload any material that infringes the intellectual property rights of any other party. We accept no responsibility for your actions in either
 uploading material to the Internet or in your transferral of any material to other websites (or vice versa);
- You do not upload any material that may be considered to be contrary to public decency and morality including (but not limited to) pornographic, barbaric
 and overtly tasteless material. We reserve the right to randomly inspect the Web Site and in the event that any unauthorised material has been uploaded
 to that Web Site, we reserve the right to inform the relevant authorities and to terminate this Contact forthwith;
- You do not use our servers or network to send unsolicited or spam e-mail to other Internet users regardless of whether we are referred to or not either directly or indirectly in such postings. Failure to meet this obligation would result in the termination of any contract without refund.
